The online form is limited to requests to use alternatives submitted under 10 CFR 50.55a(z). The NRC online submission form was created by the Division of Operating Reactor Licensing and the EMBARK Venture Studio in the Office of Nuclear Reactor Regulation in coordination with the Office of the Chief Information Officer.
