Dear Dr. Diaz-Montes:

This is in reference to your Decommissioning Funding Plan (DFP) dated April 29, 2019, submitted with the renewal of your license dated October 31, 2019, the revised DFP also dated April 29, 2019 document submitted with the email dated April 28, 2020, and the surety bond dated April 3, 2020. My apologies that I missed this before at the time that I requested you to provide a new Surety in the new amount of financial assurance. In addition to the Surety which was provided, the amount of financial assurance is also stated on other documents that now need to be replaced. In order to continue our review, we need the following additional information:

1. The current Certification of Financial Assurance (CFA) dated May 21, 2010 [ML101450231] lists the previous amount of financial assurance. Please submit a new CFA for the new amount of financial assurance as stated on the Surety Bond dated April 3, 2020 [ML20135H156]. Please note that the CFA is a document that requires a signature, however it is not required to be an original documents. You may send pdf copy of the signed document, or a digital-signature copy, attached to an email.
2. Schedule B of the current Standby Trust Agreement (STA) dated August 24, 2012 [ML12265A067] was revised by an amendment dated April 11, 2017 [ML17277B155]. Schedule B of the STA specifies the amount of financial assurance provided, and needs to be revised again for the new amount of financial assurance. Please note that Schedule B does not require a signature and may be submitted as a pdf attached to an email.
