Dear Mr. Knighton:

The attached information is provided in response to your letter of April 30, 1986 (2CNAØ486Ø4) requesting AP&L's review of the ANO-2 specific Generic Requirement List. Due to the short time frame in which you requested our response and the brief subject descriptions provided, we were unable to determine the subject licensee action on a number of the items. We understood your letter to request the best information that was quickly available in order to meet your schedule. To accommodate this schedule our normal review and verification process was circumvented. A'though the information is believed to be accurate and reflective of the status, proper verification should be obtained before officially using this information.

The information you provided was integrated and reproduced in the attached tabular format. Added is a Licensee Status column and a Comment column. In the Licensee Status column we have provided the date (month and year) in which the item was closed or will be closed. A "C" follows the date for
