Thank you for your letter of October 3, 1988, in response to our letter and the attached Notice of Violation (NOV) dated September 16, 1988. As a result of our review, we found that additional information is needed. This matter was discussed between you and Mr. Russell Wise of this office during a telephone conversation on November 8, 1988. Specifically, you should address the following questions for each violation identified in the NOV: (1) the reason for the violation, if admitted, (2) the corrective steps which have been taken and the results achieved, (3) the corrective steps which will be taken to avoid further violations, and (4) the date when full compliance will be achieved.

Please provide the supplemental information within 10 days of your receipt of this letter so that we can continue our review of this matter.

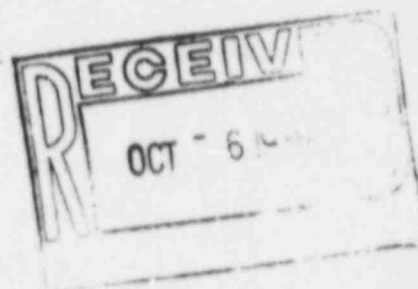

Gentlemen:

In response to the specifics contained in your Notice of Violation letter dated September 16, 1988.

Artical #1: We have received our license amendment to include the Gulf Nuclear model CSV, also we have made arrangements with SIE WoodGroup to exchange RL-1 for CSV models as soon as our leak wipe test are back.

Article #2: Annual Inspection: Due to lack of work, part of our logging supervisors have not made a R/A logging job. The ones that have, I have monitored their work and documented it. Also during most of the time from July 1987 until August of 1988 we were in the process of filing our license and was not sure what the exact forms would be used.

Article #3: Semiannual Inspection Form: We had not done a semiannual inspection because we have done one on a daily basis and beleived this was better than twice a year. It is in our manuel as Figure 1A and is on the reverse side of our Radio-active material utilization survey, figure #1, which we fill out every job. After examining our manuel if this form is not sufficient please notify us, as it was accepted in our license.

Article #4: Temporary Job Site: Our manuel on operation & emergency procedures were off the trucks being revised. They are now back on the necessary trucks, along with our latest calibration of survey meter, survey records, and shipping papers.


