Failure to Adequately Test Containment Air Recirculation Fans in Accordance with Technical Specification Surveillance Requirement 4.6.2.1.2(a)

This letter forwards Licensee Event Report (LER) 98-023-00, documenting a condition that was discovered at Millstone Nuclear Power Station, Unit No. 2, on September 24, 1998. This LER is being submitted beyond the 30-day discovery time period, as specified in 10 CFR 50.73(d), due to the time required to confirm whether or not the testing procedure used satisfied the technical specification surveillance requirement. On October 20, 1998, it was determined that although the testing appeared to meet the intent of the surveillance requirement, it did not meet the literal interpretation. As a result, this LER is being submitted pursuant to 10 CFR 50.73(a)(2)(i).
