Dear Sir:

The purpose of this letter is to submit License Amendment Request (LAR) #221, Revision 2, proposing a change to Improved Technical Specification (ITS) 5.7.2, "Special Reports." ITS 5.7.2.6, as proposed in References 1 and 2 (LAR #221, Revision 0 and LAR #221, Revision 1), includes special reporting requirements associated with the "B" Once Through Steam Generator (OTSG) inservice inspections. The proposed item required submittal of a summary of analyses, based on a probabilistic structural integrity assessment for the first span pit-like intergranular attack (IGA) indications 90 days after startup (breaker closure). Florida Power Corporation (FPC) is proposing herein to change the type of structural integrity assessment required from probabilistic to deterministic. This change is consistent with the latest industry guidance provided in Draft Regulatory Guide DG-1074, "Steam Generator Tube Integrity."

Revised ITS page 5.0-29A is included as part of this submittal. The previous conclusion of No Significant Hazards Considerations, as noticed in the Federal Register (62 FR 54873-54874) will not be affected by this proposed change in assessment approach.






