Statement of Organization and General Information; Minor Amendments

AGENCY: Nuclear Regulatory Commission.

ACTION: Final rule.

SUMMARY: The Nuclear Regulatory Commission is revising its statement of organization and general information to reflect the reorganization within the Office of Administration, the creation of the Office of the Chief Information Officer and the creation of the Office of the Chief Financial Officer. These changes are necessary to inform the public of these administrative changes to the NRC's regulations.

SUPPLEMENTARY INFORMATION:

On April 21, 1997, the NRC announced the reorganization of the Office of Administration effective April 15, 1997. The purposes of the reorganization were to (1) further emphasize the Office's service philosophy by centralizing employee services in a new Division of Administrative Services encompassing an Administrative Services Center, (2) gain efficiencies by integrating the functions of security and facilities management in a single organizational unit; (3) streamline ADM's structure by improving the supervisor/employee ratio; and, (4) accomplish other operational efficiencies.

This final rule also notifies the public that the Office of Information Resources Management and the Office of the Controller have been abolished and that the functions of these offices have been incorporated into the newly created Office of the Chief Information Officer and the Office of the Chief Financial Officer respectively.

This final rule also notes the name change of the Office of Personnel to the Office of Human Resources and other minor administrative changes.

Because these amendments deal with agency practice and procedures, the notice and comment provisions of the Administrative Procedure Act do not apply pursuant to 5 U.S.C. 553(b)(A). The amendments are effective upon publication in the Federal Register. Good cause exists to dispense with the usual 30-day delay in the effective date because these amendments are of a minor and administrative nature, dealing with the agency's reorganization.

Environmental Impact: Categorical Exclusion

The NRC has determined that this final rule is the type of action described in categorical exclusion 10 CFR 51.22 (c) (2). Therefore, neither an environmental impact statement nor an environmental assessment has been prepared for this final rule.

Paperwork Reduction Act Statement

This final rule contains no information collection requirements and, therefore, is not subject to the requirements of the Paperwork Reduction Act of 1980 (44 U.S.C. 3501 et seq.).

(d) Develops and implements policies and procedures for administering the Regulatory Flexibility Act and provides editorial and related publications services.

Executive Director for Operations

§1.32 Office of the Executive Director for Operations.

(f) Provides guidance and oversight for the selection, control and evaluation of information technology investments.

(g) Provides oversight and quality assurance for the design and operation of the Licensing Support System (LSS) services.

The Office of the Chief Financial Officer ---

(c) Provides an agency-wide management control program for financial and program managers that established internal control processes and provides for timely corrective actions regarding material weaknesses that are disclosed to comply with the Federal Manager's Financial Integrity Act of 1982.

(d) Develops and manages an agency-wide planning and budgeting process.

(e) Develops and maintains and integrated agency accounting and financial management systems, including financial reporting and internal controls.

(f) Directs, manages and provides policy guidance and oversight of agency financial management personnel activities, and operations.

(g) Prepares and transmits an annual report to the Chairman and the Director, Office of Management and Budget.

(h) Monitors the financial execution of NRC's budget in relation to actual expenditures, controls the use of agency funds to ensure that they are expended in accordance with applicable laws and financial management principles, and prepares and submits to the Chairman timely cost and performance reports and,

(i) Reviews, on a periodic basis, fees and other charges imposed by NRC for services

The Commission is responsible for licensing and regulating nuclear facilities and materials and for conducting research in support of the licensing and regulatory process, as mandated by the *Atomic Energy Act of 1954*, as amended, the *Energy Reorganization Act of 1974*, as amended, and the Nuclear Nonproliferation Act of 1978; and in accordance with the National Environmental Policy Act of 1969, as amended, and other applicable statutes. These responsibilities include protecting public health and safety; protecting the environment; protecting and safeguarding materials and plants in the interest of national security; and assuring conformity with antitrust laws. Agency functions are performed through standards-setting and rulemaking; technical reviews and studies; conduct of public hearings; issuance of authorizations, permits, and licenses; inspection, investigation, and enforcement; evaluation of operating experience; and confirmatory research. The Commission is composed of five members, appointed by the President and confirmed by the Senate, one of whom is designated by the President as Chairman.

The Chairman is the principal executive officer of and the official spokesman for the NRC, as mandated by the Reorganization Plan No. 1 of 1980. As principal executive officer, the Chairman is responsible for conducting the administrative, organizational, long-range planning, budgetary, and certain personnel functions of the agency. He/she has ultimate authority for all NRC functions pertaining to an emergency involving an NRC license. His/her actions are governed by the general policies of the Commission.

Committees and Boards

Advisory Committee on Reactor Safeguards

Has statutory responsibilities as described in the Atomic Energy Act of 1954, as amended. Reviews and advises the Commission with regard to the licensing and operation of production and utilization facilities and related safety issues, the adequacy of proposed reactor safety standards, technical and policy issues related to the licensing of evolutionary and passive plant designs, and other matters referred to it by the Commission. Upon request, reviews and advises with regard to the hazards of the Department of Energy (DOE) nuclear activities and facilities and provides technical advice to the DOE Nuclear Facilities Safety Board. On its own initiative, may conduct reviews of specific safety-related items. Submits an annual report to the U.S. Congress commenting on the NRC Safety Research Program.

Responsible for licensing issues and regulatory policy concerning reactor operators, including the initial licensing examination and requalification examinations; emergency preparedness, including participation in emergency drills with federal, state, and local agencies; radiation protection; security and safeguards at such facilities, including fitness for duty; and the inspection of nuclear component supplier facilities. NRR responsibilities include the technical review, certification, and licensing of advanced reactor facilities and the renewal of current power reactor operating licenses.

Office of Nuclear Material Safety and Safeguards

Responsible for the public health and safety licensing, inspection, and environmental reviews for all activities regulated by the Nuclear Regulatory Commission (NRC), except reactors, and for the safeguards uschnical review of all licensing activities, including export/import of special nuclear material, but excluding reactors. Administers and manages the NRC occupational safety and health programs including oversight of the workers' compensation and employee assistance programs; and the headquarters child care facility, health unit, and fitness center. Provides advice and support for the planning, development, implementation, oversight, and evaluation of HR information systems. Conducts HR budget formulation, justification, and execution; manages the development and implementation of OP accounting systems and carries out financial management coordination. Develops and implements the HR strategic plan; devises both short- and long-range plan consistent with agency-wide programmatic goals and objectives; assists and advises NRC management in the planning and implementation of HR goals consistent with agency policies and mission.

Office of Small Business and Civil Rights

Provides overall policy program evaluation and management direction for small business, civil rights, and affirmation action and federal women's program areas.

Develops and implements an effective small business program in accordance with the Small Business Act as amended. Administers the Historically Black Colleges and Universities Program pursuant to the Executive Order. Ensures that appropriate consideration is given to women and minority business enterprises. Maintains liaison with other government agencies and trade associations. Coordinates efforts with appropriate NRC offices. Develops and recommends for approval by the Executive Director for Operations the overall NRC policy providing for equal employment opportunity in all aspects of federal personnel practice. Develops, monitors, and evaluates the Affirmative Employment Program plan to assure compliance with NRC policy. Serves as contact with local and national public and private organizations to facilitate the NRC Equal Employment Opportunity Program.
