Dear Mr. Kingsley:

We have received the enclosed Federal Emergency Management Agency (FEMA) correspondence dated November 10, 1998 transmitting the FEMA final evaluation report for the August 26, 1998 Emergency Preparedness Exercise at the Quad Cities Nuclear Generating Station.

One deficiency was identified during the exercise regarding a failure to coordinate the formulation and dissemination of accurate information and instructions to the public at Scott County. There were two Areas Requiring Corrective Action (ARCA) identified during the exercise. One ARCA was corrected during the exercise and the second ARCA was corrected during the Duane Arnold October 21, 1998, exercise.

We fully recognize that any corrective actions to be implemented may involve parties and political institutions which are not under your direct control. Nonetheless, we expect that assistance, if appropriate, will be extended.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed FEMA correspondence will be placed in the NRC Public Document Room.
