Pursuant to 10CFR50.90, Northeast Nuclear Energy Company (NNECO), in a letter dated October 7, 1997, proposed to amend Operating License NPF-49 by incorporating revisions into the Millstone Unit No. 3 Technical Specifications. Contained within Attachment 3 to the letter were retyped Technical Specification pages which incorporated the proposed revision. However, the retyped pages 3/4 6-2 and B 3/4 6-1 did not accurately reflect the proposed revision. Therefore, NNECO requests that the NRC Staff replace the retyped Technical Specification pages 3/4 6-2 and B 3/4 6-1 contained in our October 7, 1997 letter with the replacement pages contained within this letter.
