We suggest that the licensee be directed to inform AEC of the action which will be taken to correct the items of noncompliance and the date when such action will be completed. The report notes that the licensee has conducted surveys which now indicate that personnel are being exposed to concentrations of airborne material in excess of AEC standards and that the concentrations of uranium in airborne effluents and of radium in liquid effluents also exceed AEC standards.
