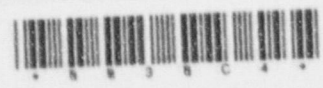

The purpose of this modification is to extend the period of performance at no additional cost through January 10, 1998. Accordingly, the contract is hereby modified as follows:

- 1) Subsection B.3, paragraph (d) is deleted in its entirety and replaced with the following:

"It is estimated that the amount currently allotted will cover performance through 1/10/98."

- 2) Paragraph F.7 is deleted in its entirety and replaced with the following:

"This contract shall commence on 7/28/94 and will expire on 1/10/98."
