Dear Mr. Grimsley:

I understand from my telephone conversation with David Meyer of your office earlier today that you desire to "close out" FOIA-84-516 on the basis of your recent provision to us of the documents described in Appendix P to FOIA-84-293. We are not presently in a position to agree that you have fully complied with FOIA-84-516. We are continuing to review the documents recently provided to ascertain what gaps, if any, we believe exist.

In the meantime, however, we request that you provide us with true copies of each of the 47 documents listed in Appendix P, item 101 (FOIA-84-293), in exactly the same form as they were reviewed by your Case Study C study team. In addition, we reiterate our request for the information upon which the conclusions of Case Study C are based, including all NRC and NRC-retained consultant interview notes, meeting minutes, transcripts, and other information secured in the preparation of Case Study C. This would include the bases for the factual statements, opinions and conclusions embodied in Mr. Altman's notes of 1/28/83, Appendix P, items 102 and 103 (FOIA-84-293). We are particularly desirous of obtaining the complete notes and other records of interviews or meetings with Pacific Gas & Electric Company's officers, employees, consultants, subcontractors, etc. These materials were plainly comprehended by Mr. O'Neill's request of June 19, 1984. We ask that you contact all NRC employees and consultants who worked on Case Study C in order to identify such documents and secure them for our use. As indicated in our previous correspondence, such information may prove to be extremely important in facilitating the completion of our study of the reasonableness of Diablo Canyon costs and in securing California's legitimate interest in exercising its traditional authority over ratemaking.

Your recent effort to cooperate with our request is very much appreciated, and we are hopeful that your continuing cooperation
