This facility has not been in operation since February, 1972, but we may wish to activate it at some future date and therefore do not wish to abandon its licensing.

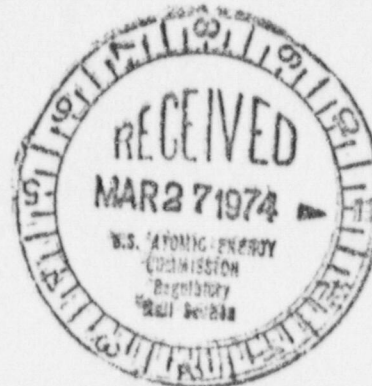
