Descriptive Title: Uranium Shipment Accident

A. Date and Manner AEC was Informed

On August 4, 1971, at 7:20 p.m., Mr. Herman J. Paas, Jr., of the Denver Regional Office, received a phone call from the Colorado State Patrol, Denver Dispatcher.


P. Description of Particular Event or Circumstance

The dispatcher stated that a truck carrying a radioactive shipment of yellowake was involved in a ditching accident at 6364 North Washington Street, Denver, Colorado, and State Patrol, who were at the accident scene, wanted instructions, as one barrel was observed to be broken. The dispatcher (Miss Lapenne) was informed that the Colorado State Department of Health was the agency responsible for handling an accident of this type in Colorado. In response to Miss Lapenne's request, Mr. Paas volunteered to notify Mr. R. Siek, Chief, Radiation Hygiene Section, Colorado State Department of Health. Following inquiry as to what instructions to pass on to the patrolman at the accident scene, Mr. Paas stated that the area should be guarded to preclude any tracking or spread of the spilled material; based on the description, the direct radiation hazard was stated as being minimal and apparantly not requisite of any other precautions. Mr. Siek was contacted at 7:25 p.m., and informed Mr. Paas that he and his personnel would proceed to the accident scene at once. Mr. Paas called Miss Lapenne, informing her that the State people had been contacted and were on their way to the scene. (Newspaper photo attached.) Mr. Paas contacted the Colorado State Department of Health (Mr. Montgomery) on the morning of August 5, 1971, for purposes of determining if any other followup actions on the part of the Denver Regional Office were required. Mr. Montgomery stated that the contents were reloaded

on to another truck and this vehicle, along with the contaminated 'vehicle, were taken to the carrier's Denver depot. Western Nuclear, Inc., was notified of these actions by the State and the shipment now awaits arrival of Western Nuclear personnel who will complete decontamination and arrangements to forward the intact portion of the shipment. On August 6, 1971, Mr. Paas informed Mr. Steve Farkas, Coordinator Regional Radiological Assistance Team, National Reactor Testing Station, Idaho Falls, Idaho, of the facts summarized above. Considering the minimal hazard, negligable public relations problem and the effective actions of the Colorado State Department of Health, it was agreed that no further action on the part of the Radiological Assistance Team were needed. C. Action by Licensee At approximately 8:30 p.m., Mr. Bondie Tuverson, Radiation Safety Officer, Western Nuclear, Inc., Jeffrey City, Wyoming, called Mr. Paas regarding the accident. Mr. Tuverson stated that the shipment belonged to Western Nuclear and was in transport to the United Kingdom AEC, via the port of Baltimore, Maryland. He stated he was debating the need for sending a man to Denver for nonitoring and cleanup purposes and asked advice in this request. Mr. Paas advised that he contact the Colorado State Department of H alth (Mr. Siek) for updated information, and base his decision on the observations made at the accident scene. Mr. Tuverson s ated he would take this course of action. The De ver Regional Office plans no further action and considers the incident closed. Prepared By: Herman J. Truck overturns, spilling radioactive powder

A truck hauling 44 barrels of uranium oxide overturned Wednesday night at E. 63rd Avenue and Washington Street, Adams County, spilling a small amount of the black radioactive powder from one barrel.

Jim Montgomery, health physicist for the Colorado Health Department, said the 1,000cent of uranium.

Uranium oxide is the concentrated matter produced when uranium ore is processed.

Montgomery said the truck, owned by the Yellow Freight Lines of Denver and driven by Don Birdsall, was parked on Washington Stree;

pound barrel contained only 3 per cent to 5 per next to an irrigation ditch when the front wheels slid into the citch.

Birdsall called a tow truck, but when the truck was being pulled out, it slide all the way into the ditch and overturned, Montgomery said.

A small portion of one of the 50-galloss barrels spilled inside the truck, but will not be dangerous to clean up, the health officials said.
