I appreciated your telephone call on October 27, 1969 regarding our Application for a Source Material License, Docket Number 40-7869.

We agree to conduct the Air Sampling Program which you requested at each facility where employees are required to work around any source materials. We understand and agree that all crushing and grinding operations shall be considered as part of the processing and milling operations and shall be covered under this Source Materials License.

We will comply with all regulations of the State of Utah governing the reclamation of all mill tailings and mine waste areas. All mill tailings will contain less than 0.05% uranium oxide.

We will start the construction work and the water drilling operations immediately. We will look forward to receiving our Source Material License within the next few days.
