Dear Ms. Drennan:

This responds to your letter of October 20, 1989, in which you requested a further extension of time for submission of Safety Light's Trust Agreement and Work Plan.

In light of the progress that Safety Light is making in preparing and submitting a trust agreement, including forwarding a copy of the draft for our review, we are granting the requested extension of time for both submitting the Trust Agreement and the Work Plan.

Notwithstanding the recent action by the Atomic Safety and Licensing Board in granting a stay, we urge you and your client to continue to finalize the Trust Agreement, and as soon as appropriate, submit it and fund the trust. We would expect to receive the Work Plan no later than three weeks after the trust is funded.

In the future, to enable us to more promptly respond to you, please address correspondence related to requirements of the March 16 or August 21, 1989 Orders, or requests for relaxation, rescission or modification of the Orders, to me at the address shown above. Also, please send copies to Mr. Hugh L. Thompson, Deputy Executive Director for Nuclear Materials Safety, Safeguards and Operations Support; Mr. James Lieberman, Director, Office of Enforcement; and to Mr. Bernard M. Bordenick, Office of the General Counsel, at the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington D.C. 20555. Please address correspondence relating to litigation of the Orders to Mr. Bordenick, with copies to Mr. Thompson, Mr. Lieberman and me.
