Enclosed are the following emergency response procedure revisions to the Common Nuclear Emergency Plan (i.e. ERP-Cs) for Peach Bottom Atomic Power Station (PBAPS), Units 2 and 3, and Limerick Generating Station (LGS), Units 1 and 2, and the Emergency Response Procedures (ERPs) for PBAPS, Units 2 and 3.

Emergency response procedure revisions are required to be submitted within thirty (30) days of their revision in accordance with 10CFR50, Appendix E, and 10CFR 50.4. However, the procedures identified above, with the exception of ERP-301, Rev. 3, were not submitted within 30 days of their revision as required by 10CFR50, Appendix E, Section V, as a result of an administrative oversight. We apologize for any inconvenience this may have caused.


