On September 9-10, 1997, Penny Lanzisera and Keith Brown of this office conducted a safety inspection at the above address of activities authorized by the NRC licenses listed below. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with you and several members of your staff, at the conclusion of the inspection. This also refers to the telephone conversation on September 17, 1997, between Penny Lanzisera and 1LT Kenneth Guiberson, your Radiation Safety Officer.

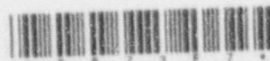
