

Regulatory Commitment Revision Report

January 26, 1998

- Original Document: NRC Inspection Report 237(249)-92067; Enforcement Conference Inspection Report 237(249)-92012 .
- Subject of Change: Use of a checklist similar to the one used by NED for 10 CFR 50.59 Safety Evaluations and Screenings.
- Original Commitment: DAP 10-2 will be revised to require the use of a checklist (similar to that used by NED) to provide written negative conformation of design issues when completing a 10 CFR 50.59 screening or Evaluation.
- Revised Commitment: Revised to state that the "Design Issues Worksheet" should be used for 10 CFR 50.59 Safety Evaluations and Screenings.
- Basis: The change to this commitment is to change the word shall to should. The revision does not preclude the use of the checklist, but no longer mandates usage for all Evaluations and Screenings.
- Original Document: TPJLTR: 95-0062, "Response to SALP 13 Report for Dresden Station".
- Subject of Change: Utilization of Peer Evaluators from industry top performers to perform quarterly reviews of Radiation Protection (RP) trends.
- Original Commitment: Peer evaluators from industry top performers will be utilized for quarterly reviews of RP trends.
- Revised Commitment: Deletion of Commitment
- Basis: The original commitment was not specific with relation to time. Quarterly reviews were conducted until the time of this action. Due to improvements in the RP area this commitment was eliminated.
