Dear Ms. Griffin:

This refers to the inspection conducted on December 3, 1998, at Indiana University Medical Center and the continued in-office review of the misadministration report dated December 18, 1998. The purpose of the inspection was to review an event that Indiana University School of Medicine reported to the U.S. Nuclear Regulatory Commission (NRC) as a misadministration on December 2, 1998, involving a gamma stereotactic radiosurgery treatment that occurred on December 1, 1998, and to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with members of your staff.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel. The NRC contracted a medical consultant, Richard Whittington, M.D., to review the medical significance of this incident. A copy of the results of Dr. Whittington's evaluation will be provided to you by separate correspondence.

No violations of NRC requirements were identified during the course of the inspection.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and the enclosure to this letter will be placed in the NRC Public Document Room.
