Dear Dr. Barreras:

I am responding to your two letters dated August 15, 1997, regarding the change of the status of License No. 52-21485-01. Your letters state that you are considering changing from "storage only," to active use, and would like information regarding the new fees associated with the license. The fee required to reinstate an expired, terminated, or inactive license (such as "storage only") to active status is an application fee. The application fee for a Fee Category 7C medical use license, such as yours, is \$1,800. The current fee schedule is enclosed for your use.

Once you convert your status from "Storage Only" to an active license you will also be subject to annual fees. The current annual fee for Fee Category 7C is \$4,700. The NRC offers reduced fees for small entities. Please see the enclosed Materials Annual Fee Billing Handbook.

I have forwarded one of your letters to the Region II Licensing staff located at 61 Forsyth Street, S.W., Suite 23T85, Atlanta, Georgia 30303-3415, for appropriate action. Enclosed is our NRC Form 577, "License Fee Requirements" which we sent you on September 16, 1997. If you have any additional questions, please contact Rita Messier at 301-415-6067.
