This refers to the special safety inspection conducted by Mr. J. Mullauer and Ms. T. Simmons, of the NRC Region III office, on March 4 and 5, 1986, and to the routine safety inspection conducted by Mssrs. J. Miller, J. Jensen, and S. Courtemanche of this office on April 21, 22, 24, 25, 29 and May 13, 1986, of activities authorized by NRC License No. 37-00276-25 and to the discussions of our findings held by Mr. Mullauer and Mr. Miller with yourself and/or members of your staff at the conclusion of the two inspections. This also refers to the subsequent telephone discussion between yourself and Mr. J. Joyner of this office on June 13, 1986.

Areas examined during these inspections are described in the NRC Region I Inspection Reports which are enclosed with this letter. Within these areas, the inspections consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

As discussed during the telephone conversation between yourself and Mr. Joyner, the apparent violations identified during these inspections will be discussed at an Enforcement Conference at our office in King of Prussia, Pennsylvania at 1:00 p.m. on June 27, 1986. We understand that Mr. Kingsley Drake will attend this meeting. He should be prepared to discuss the causes for these apparent violations and your proposed corrective action. Enforcement action for these violations will be considered by the NRC following the Conference. The NRC Enforcement Policy is described in Appendix C of 10 CFR Part 2, a copy of which is enclosed for your information.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.
