The purpose of this modification is to incorporate the following changes in the award/contract. Accordingly, the contract is hereby modified as follows:

- 1) In Section B, SUPPLIES OR SERVICES AND PRICES/COSTS, Subsection B.4, paragraph (d) is deleted in its entirety and replaced with the following:

"It is estimated that the amount currently allotted will cover performance through 9/31/96."

- 2) In Section F, DELIVERIES OR PERFORMANCE, Subsection F.2 is deleted in its entirety and replaced with the following:

"The contractor shall submit the following reports accordingly.

**TASK 1 - INITIAL WORK PLAN**

Draft Due: 30 days after initial planning meeting

NRC comments/approval will be provided within 10 days of receipt of plan

**TASK 2 - LETTER REPORT**

Draft Due: 11 months after approval of the Task 1 work plan

Final Due: 60 days after receipt of NRC comments/approval

**TASK 3 - LETTER REPORT**

Draft Due: 23 months after approval of the Task 1 work plan

Final Due: 60 days after receipt of NRC comments/approval

**TASK 4 - LETTER REPORT**

Draft Due: 30 months after approval of the Task 1 work plan

Final Due: 60 days after receipt of NRC comments/approval

**TASK 5 - NUREG/CR REPORT**

Draft Due: 32 months after effective day of the contract

Final Due: 2 months after receipt of NRC comments/approval and before the end of the 36-month period of performance
