Dear Mr. Kokke:

I am responding to your May 29, 1997, letter in which you stated Zynaxis, Inc., does not exist anymore, and your September 4, 1996, letter stating that the main activities of Zynaxis, Inc., were development of oral vaccines and the manufacture of fine chemicals and pharmaceuticals.

Based on the above, we are requesting that the U.S. Small Business Administration (SBA) make a formal size determination and SIC code designation for Zynaxis, Inc., Cauldron Process Chemistry and any other related companies (see the enclosed copy of 13 CFR 121.503 and 13 CFR 121.901). In addition to any notification the SBA may provide you, the NRC will inform you of the resulting action with regard to the NRC's annual fees. In accordance with 10 CFR 15.37(j), I am extending the interest-free waiver period until a final determination is made for any additional amounts that may be due for invoices AM2787-97 and AM2491-96.

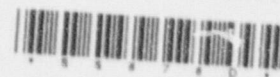

Sec. 121.503 Are SBA size determinations binding on parties?

Formal size determinations based upon a specific Government sale or lease, or made in response to a request from another Government agency under Sec. 121.901, are binding upon the parties. Other SBA opinions provided to contracting officers or others are only advisory, and are not binding or appealable.

#### SIZE ELIGIBILITY REQUIREMENTS FOR COMPLIANCE WITH PROGRAMS OF OTHER AGENCIES

Sec. 121.901 Can other Government agencies obtain SBA size determinations?

Upon request by another Government agency, SBA will provide a size determination, under SBA rules, standards and procedures, for its use in determining compliance with small business requirements of its statutes, regulations or programs.
