Dear Major General Mabry:

On December 10, 1998, the NRC completed an inspection at Bolling Air Force Base (AFB), Washington, D.C. The purpose of the inspection was to determine whether activities authorized under NRC License 42-23539-01AF were conducted in accordance with NRC requirements.

The inspection included a review of activities associated with the U.S. Air Force (USAF) master material license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. Special emphasis was placed on several major areas within the USAF program including: (1) permitting activities, (2) inspection activities, (3) decommissioning activities, and (4) the Radioisotope Committee (RIC) management oversight of program activities. These areas are described in more detail in the attached report. Within the scope of this inspection no violations or deviations were identified; therefore, no response to this letter is required.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be placed in the NRC Public Document Room.
