

The purpose of this modification is to allot \$600,000 in incremental funds to this contract. Accordingly, the contract is hereby modified as follows:

1. Paragraphs (c) and (d) of Section B.3 are revised to read as follows:

"c. The amount presently obligated by the Government with respect to this contract is \$2,003,300 of which the sum of \$1,809,517 represents the reimbursable costs, of which the sum of \$25,498 represents facilities capital cost of money, and of which the sum of \$168,285 represents the fixed fee.

d. It is estimated that the amount presently obligated will be sufficient to continue performance through September 30, 1998."
