Option B. Modification

Reference (a) proposed a change to Appendix A of the subject license. A review of reference (a) revealed that corrections were required to conform two mark-up pages and their corresponding print ready pages. These corrected pages were provided to the Staff via reference (b).

Subsequent reviews have identified that additional changes are warranted to the reference (b) submittal. Specifically, mark-up page 147, section 4.7.A.2, should read "Leak" as opposed to "Leakage," and mark-up page 157, section 3.7.D.2, should read "containment isolation valve" as opposed to "isolation containment valve."

It is noted that a detailed review of the print ready and mark-up pages for this proposed change has been completed. This review identified additional typographical errors on several of the remaining pages. Accordingly, all pages submitted in Reference (a) are being resubmitted with the typographical errors corrected. The correction of these errors does not alter the Safety Considerations, Significant Hazards Considerations, or Environmental Considerations of reference (a).
