Dear Mr. Kingsley:

On January 30, 1998, the NRC completed an inspection of your emergency preparedness program at the LaSalle Generating Station, Units 1 and 2. The enclosed report presents the results of that inspection.

Areas examined within your emergency preparedness program are identified in the report. Within those areas, the inspection consisted of a selective examination of procedures and representative records, interviews with personnel, and observation of activities in progress. The objective of the inspection effort was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

During this inspection our evaluation of your activities showed the emergency preparedness program to be adequately implemented. In particular, emergency response facilities, equipment, and supplies had been well maintained, management attention to the program was indicated, and interviewed emergency response personnel demonstrated competent knowledge of responsibilities and emergency procedures.
