Based on the information furnished us, we have determined that the transfer of the license is in accordance with the Atomic Energy Act of 1954, as amended. We hereby give NRC's consent to some pursuant to 10 CFR 30.34(b). However, the transfer of license should not have taken place until the NRC had given its written consent, as required by 10 CFR 30.34(b). The transfer prior to NRC consent is a violation of this regulation as described in the enclosed Notice of Violation.

You are not required to respond to this letter unless the description of your October 13, 1997, letter does not accurately reflect your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice of Violation.
