Re: Allied Fidelity Insurance Company

Dear Mr. Eakin:

You may or may not be aware that that the State of Wyoming is involved in litigation with the Allied Fidelity Insurance Company which was ordered into rehabilitation on March 5, 1986, by Marion County Circuit Judge John M. Ryan. I have obtained a copy of that order and believe it is appropriate to inform you of the situation here in Wyoming.

Enclosed for your information is a copy of an order by the Wyoming Insurance Commissioner suspending Allied's certificate of authority to do business in this state. These developments are of immediate concern because my office is attempting to collect \$441,000 from Allied on a reclamation performance bond for an insitu uranium mine which has been abandoned by its owners and operators. The abandonment of the mine threatens radioactive contamination of the groundwater and of any persons who may come into contact with materials at the surface facilities unless adequate security is maintained and proper reclamation and disposal are accomplished. Allied has so far resisted paying on the bond despite an order of the Wyoming Environmental Quality Council declaring the bond to be forfeited in accordance with the procedures set out at Wyoming Statute 35-11-421 (copy attached).

The litigation involves a petition for judicial review of the Council's ruling that Allied did not have standing to object to the forfeiture proceedings. (The statute provides that the surety is to receive notice, but only the operator can demand a hearing; and no operator appeared in protest.) The Department of Environmental Quality has responded with a petition for declaratory judgment on Allied's bond and with a motion for

summary judgment. Allied has filed a motion to dismiss and a motion to strike the documents offered by the Department. A hearing on some (and perhaps all) of the motions will be held at 9:00 a.m., on April 7, 1986, before State District Judge Leonard McEwan, at the Laramie County Courthouse in Cheyenne, Wyoming.

In view of the fact that your office now has control over Allied's assets and exercises management authority over the company under court supervision, I ask you to consider your position in the Wyoming Litigation. Do you intend to pursue the course initiated by Allied's local counsel in the case, who is John A. Sundahl, of Godfrey & Sundahl, 2020 Carey Avenue, Suite 403, P.O. Box 328, Cheyenne, Wyoming 82003 (telephone 307-632-6421)? Would you please inform me of your decision before April 7.

To assist you in reviewing this matter, I am also enclosing copies of the notice and order of forfeiture, the petition for judicial review, and the State's response, together with a copy of Allied's bond, but without many of the offered exhibits. It is my opinion that Allied was stalling for financial reasons, and not because of any lack of due process, nor for any of the other grounds of objection it has attempted to raise.

It would be my hope that you will recognize the lawful actions of the Wyoming Department of Environmental Quality and the Wyoming Environmental Quality Council.
