Gentlemen:

This refers to the inspection conducted by Mr. A. B. Earnest of this office during the period June 16-20, 1986, of activities authorized by NRC Operating License DPR-34 for Fort St. Vrain Nuclear Station, and to the discussion of our findings with members of your staff at the conclusion of the inspection.

Areas examined during the inspection included access control - vehicles, access control - packages, compensatory measures, and access control - vital area. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are documented in the enclosed inspection report.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 2 of the enclosed report.

Within the scope of the inspection, no violations or deviations were identified.
