IE Bulletin 85-03, Motor Operated Valve Common Mode Failures During Plant Transients Due To Improper Switch Settings, November 15, 1985, requested a response concerning each licensee's program for selecting, setting and maintaining the switches of the motor-operated valves in the high pressure coolant injection/core spray and emergency feedwater systems.

Your response, letter JAFP-86-0437 dated May 14, 1986, although indicating that a program to accomplish items (b) through (d) of the Bulletin exists, did not supply the program as requested. Accordingly, please submit a revision to your response to IE Bulletin 85-03 which includes a detailed description of your facility's program for selecting, setting and maintaining the switches on the motor operated valves identified in item (a). Additionally, include a synopsis of your program for demonstrating operability of each valve by testing according to item (c), whether or not testing can be accomplished at present.

Please provide your revised response within 30 days of receipt of this letter.
