SAFEGUARDS INFORMATION

As discussed with Mr. Madeda, Mr. Knicely, and Mr. Kers of your office, these changes do not decrease the safeguards effectiveness of the plans. The plans are revised to enhance the operational effectiveness of the Security Program by eliminating redundancy and clarifying existing requirements.

The revisions also address NRC concerns identified in References 2 and 3 (item numbers 85047-01, 85047-20, 85047-22, and 86014-05). Additionally, changes have been incorporated into the Physical Security Plan to respond to NRC comments (contained in References 4, 5, and 6) concerning previous revisions to the Physical Security Plan.

As discussed most recently with Mr. Kers, these revisions are prepared and submitted pursuant to 10CFR50.54(p). Detroit Edison is in the process of implementing these revisions to improve the security program and to address concerns identified in references 4 through 6; however, revision 10 will not be fully implemented pending your staff's concurrence.
