This refers to the routine safeguards inspection conducted by Mr. R. J. Bailey of this office on February 18-21, 1986, at the Calvert Cliffs Nuclear Power Plant, Units 1 and 2, Lusby, Maryland, of activities authorized by NRC License Nos. DPR-53 and DPR-69 and to the discussions of our findings held by Mr. Bailey with Mr. L. P. Gibbs of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. These violations have been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (49 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Sections of the enclosed inspection report and Appendix A contain details of your security program that have been determined to be exempt from public disclosure in accordance with 10 CFR 73.21 (Safeguards Information). Therefore, the sections so identified in the inspection report and Appendix A will not be placed in the NRC Public Document Room and will receive limited distribution. This letter and the remaining portions of the inspection report will be placed in the Public Document Room, in accordance with 10 CFR 2.790(a).

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.

Your cooperation with us in this matter is appreciated.
