Please accept this letter as a formal reply to our recent conversation covering the several licenses at F.D.U.

License No. SNM-275 (expired). License application for possession only is appended. The material is to be moved to The College of Dental Medicine storage facility under my direct supervision until it can be properly disposed of.

License No. 29-07094-02 (expired). License application for continued possession is appended. It is my understanding that this irradiator has not been used for several years and no usage is anticipated. The manufacturer is no longer in business. We are actively looking for a way to properly dispose of the radioactive material. It will continue to be under the direct supervision of Dr. L. Jacobs, Professor of Biology, who, in this matter, will report to myself. I will be providing for leak-testing at six month intervals (as this unit is not in use).

License No. 29-16049-01. In response to our Notice of Violation and discussions with Mr. John Jensen, I would like to request a change in our license to read: 11.A.1. "will be calibrated annually and following repair, by the manufacturer:"

We plan to purchase a second monitor which would provide overlap, affording us the presence of a calibrated meter (essentially calibrated every six months).

License SMB-1428. The material listed under this license is to be moved for storage to the College of Dental Medicine facility under my direct supervision.


