SUBJECT: LOSS OF ONE INDEPENDENT OFFSITE CIRCUIT

At 2:24 p.m. (PDST) on May 5, 1986, the 2-1 Diesel Generator (DG) was unexpectedly started, and loaded, on a vital bus G undervoltage condition. This event was reported at 5:05 p.m. as an ESF actuation as required by 10 CFR 50.72 for 4 hour reportability.

The circumstances surrounding this event began earlier that afternoon as plant operators were stabilizing plant conditions following an automatic main turbine runback from 100% power to 20% due to loss of stator cooling water. While attempting to realign vital 4KV bus G from auxiliary power to startup power, the auxiliary power feeder breaker (52 HG 13) tripped on overcurrent and the startup power feeder breaker did not close in. This resulted in a loss of power (i.e., undervoltage) to vital 4KV bus G causing the associated DG (2-1) to start and load. After about 15 minutes, plant operators successfully transferred bus G from the diesel back to startup power. The auxiliary power supply was subsequently declared inoperable as an independent offsite circuit.

Plant operators are starting (testing) diesel generators every 8 hours in accordance with TS requirements while the electrical maintenance department conducts an investigation.
