## Ladies and Gentlemen:

Pursuant to the requirements of 10 CFR 50.55a(g) and 10 CFR 50.36, Southern Nuclear Operating Company hereby submits the Farley Nuclear Plant Unit 1, Interval 2, Period 3, Outage 3 Inservice Inspection Report (Enclosure 1) and the Interval 3, Period 1, Outage 1 Inservice Inspection Report (Enclosure 2). These reports describe and summarize the inservice inspection activities performed during the Unit 1 fifteenth refricting outage. Note that SNC had advised NRC by letter dated September 18, 1998 that activities performed during this outage would serve to fulfill certain requirements of both the second and third Inservice Inspection Intervals. These activities were completed December 26, 1998. Included in Enclosure 2 are the results of the steam generator eddy current testing conducted during this outage as required by 10 CFR 50.55a(g) and Section 4.4.6.5.b of the Farley Nuclear Plant Unit 1 Technical Specifications. A summary of these results may be found in Tab B of Enclosure 2.
