



Pursuant to the requirements of Reference 1, Nebraska Public Power District is submitting the following response:

A review of all Static "O" Ring (SOR) components installed at Cooper Nuclear Station (CNS) was performed as a result of Reference 2. This review indicated that none of the SOR D/P switch model numbers identified in Reference 1 are installed at CNS.

The only SOR D/P switches identified by this review are Model 22S-L614-CJ. They are installed in the LOGT (Turbine Lube Oil) System as

- 1. Seal oil vapor demister high D/P, and
- 2. Lube oil reservoir demister high D/P.

The LOGT system is classified as non-essential at CNS and is not subject to any Limiting Conditions for Operations in the CNS Technical Specifications.
