Dear Mr. Ray:

This refers to the inspection conducted on January 3 through February 20, 1999, at the San Onofre Nuclear Generating Station, Units 2 and 3, facility. The enclosed report presents the results of this inspection.

During the 7-week period covered by this inspection, your conduct of activities at use San Onofre facility was generally characterized by safety-conscious operation, sound engineering and maintenance practices, and careful radiological work controls.

Based on the results of this inspection, the NRC has determined that three violations of NRC requirements occurred. These violations are being treated as noncited violations (NCVs), consistent with Appendix C of the NRC Enforcement Policy. These NCVs are described in the subject inspection report. If you contest the violation or severity level of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001, with copies to the Regional Administrator, Region IV, the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001, and the resident inspector at the facility.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Documer t Room.
