Sequoyah Fuels Purchase By General Atomics

By separate letters dated October 18, 1988, Sequoyah Holding Corporation, a subsidiary of General Atomics, formally requested NRC approval of the purchase of Sequoyah Fuels by Sequoyah Holding from Kerr-McGee Corporation and a license amendment to reflect organizational and corporate oversight changes resulting from the proposed transfer of control. As requested by staff, Sequoyah Holding has provided additional information and commitments related to decommissioning funding. Staff is preparing an assessment for the proposed transfer of control of the license.

Southwestern Low-Level Radioactive Waste Disposal Compact Consent Act

The Senate passed the Southwestern Low-Level Radioactive Waste Disposal Compact Consent Act (S. 5232) on October 21, 1988. The House approved an identical bill (H.R. 5232) on Sentember 26. The President is expected to sign the legislation by October 31, thus acknowledging Congressional consent to the Compact of the eligible States of California, Arizona. North Dakota and South Dakota. To date, California and Arizona have enacted the required State legislation. South Dakota is expected to introduce such legislation in 1989. North Dakota is currently negotiating a contract for the short term with the Northwest Compact, but may wish to join the Southwestern Compact for the long term. Under the terms of the Compact, California is the host State for 30 years. California is developing a site at Ward Valley which is 25 miles west of Needles. The forecast time for operation is during 1991.

A1ChemIE

The IMNS staff issued two Safety Evaluation Reports (SERs) in connection with AlChemIE's proposals to enrich stable isotopes at facilities in Oak Ridge and Oliver Springs, Tennessee. The recently received ACRS letter, which contained favorable comments on the proposals, was enclosed with the SERs. The staff plans to issue in the near future supplements to the SERs discussing conclusions with respect to financial information.

Supervisory Drug and Alcohol Training

A pilot session of the Supervisory Drug and Alcohol Training was presented to approximately 30 managers and supervisors selected from the various offices within NRC, on Thursday, October 27, 1988. Trainers were Willard O. Foster of Triton Corporation and Pat Kaplan of the Employee Assistance Program, Office of Personnel. Participants were requested to provide comments and recommendations on the program which will be presented to all NRC managers and supervisors in Headquarters and the Regions.

LOW-LEVEL WASTE MANAGEMENT

Staff Evaluation of Waste Cement Solidification at West Valley

The LLWM staff's technical evaluation of the cement solidification of the decontaminated supernatant waste for the West Valley Project is nearing completion. The staff's evaluation is directed at assessing whether DOE's efforts in solidifying the decontaminated supernatant will produce a stable waste form that fulfills the requirements of 10 CFR Part 61. Completion of the evaluation report is scheduled for November 1988.

Regional Workshop on Decommissioning Rule

A series of workshops is planned for NRC Regional materials licensing staff to familiarize them with the requirements of the decommissioning rule issued by the Commission in June 1988.

The first workshop is scheduled for Region I on November 1, 1988, and will discuss provisions of the rule requiring financial assurances for decommissioning and acceptable mechanisms for meeting these requirements. The workshops will be conducted by staff of the Division of Low-Level Waste Management and Decommissioning in NMSS.

Environmental Assessment For Oconee ISFSI

The NRC has issued an Environmental Assessment and Finding of No Significant Impact related to the licensing of a Dry Independent Spent Fuel Storage Installation (ISFSI) at Duke Power Company's Oconee Nuclear Station. The ISFSI is to use the NUTECH Horizontal Modular System, NUHOMS-24P design. The NUHOMS-24P design stores 24 PWR spent fuel assemblies sealed in a stainless steel canister. The canister is inserted into a chick-walled horizontal

concrete module. Duke Power Company has requested licensing for up to 88 modules to provide spent fuel storage capacity for its Oconee Nuclear Station through the year 2003.

Domestic

Safeguards Staff Participating In Measurement Control Symposium At Savannah River Plant

Members of the fuel facility safeguards licensing staff participated in a DOE sponsored symposium on Measurement/Measurement Control for Material Control and Accounting on October 25-28, 1988 at the Savannah River Plant. Measurement Control is a quality assurance program for SNM measurements. The current regulations, 10 CFR Part 70 and Part 74, require fuel facility licensees to maintain an approved measurement control program. The DOE sponsored symposium provides a forum for DOE and its contractors, NRC and NRC licensees to discuss experiences and new ideas in this technical area.

International

Tracking of Australian Origin Monazite Ore

On October 24, 1988, staff attended a meeting at the Department of State with representatives of the Australian Government to exchange views on the reporting of Australian origin monazite ore imported into the U.S. pursuant to the U.S./ Australian Agreement for Cooperation. Procedures concerning the transfer and accountability of ore containing more than 0.05% by weight of uranium and/or thorium are still being negotiated.

U.S. and Canadian Support Program Consulta'.ion Meeting

On October 25, 1988, a SGTR staff member participated in the annual U.S. and Canadian support program consultation meeting at the Department of State. The meeting was devoted to the status of safeguards equipment development by the U.S. and Canadian support programs to strengthen IAEA safeguards. The Canadians presented several types of specialized equipment for safeguarding CANDU reactors.

TRANSPORTATION

Installation of QAD and ORIGENS

On October 24-25, 1988, the Transportation Branch met with Oak Ridge National Laboratory (ORNL) on the installation of QAD and ORIGENS computer programs in SGTR. The QAD program is used for neutron and gamma-ray shielding calculations. The ORIGENS program can be used to predict concentrations of fission products and actinide elements for various degrees of fuel burnup, and is able to predict decay product concentrations for various fuel cooling times. The output from ORIGENS can be used cirectly in QAD for solving shielding problems involving spent fuel transport casks.

During October 23-28, the team worked on finalizing the evaluation report, including incorporating comments from the Director and Deputy Director, AEOD.

On October 28, 1988, the Director, AEOD and McGuire DET deputy team manager attended a meeting with Duke Power executives to discuss Duke's Quality Assurance philosophy and program. The meeting was requested by Duke in response to the McGuire Diagnostic Evaluation and Catawba Quality Verification inspection.

Incident Response Branch (IRB)

On October 24-26, the IRB Branch Chief and an IRB staff member participated in the Federal Emergency Management Agency (FEMA)-sponsored regional workshop on the Federal Radiological Emergency Response Plan held in Bellevue, Washington. This workshop was designed for State and local officials, power reactor licensee staff, and regional Federal agencies in the Western U.S. (FEMA Regions 9 and 10). The workshop included presentation by the major Federal agencies and concluded with a large tabletop exercise to further explore the interfaces and relationships among the participants in a severe reactor emergency. This workshop was the prototype for others that are expected to be held in all sections of the country over the next 2 years.

INTERNATIONAL PROGRAMS:

Foreign Visitors

Un Monday Mr. Thilo Schelling and Dr. K. Kugler of the staff of Dr. Reimut Jochimsen, Minister for Economics and Technology of the West German State of North-Rhein-Westfalia, accompanied by Dr. Heinz Seipel, Science Counselor at the FRG Embassy in Washington, visited RES staff to discuss several technical issues concerning site criteria, plant backfitting, PSA, and safety research and licensing of liquid metal cooled reactors. Note: Dr. Jochimsen, the State official responsible for refusing to grant an operating license to the Kalkar SNR-300 fast breeder reactor, did not attend.

On Monday Mr. Jose Izquierdo of the Consejo de Seguridad Nuclear in Spain met with GPA/IP and NRR staff to discuss BWR instabilities after the LaSalle incident and the impact of steam generator tube plugging on transient and accident analysis review of D3.F.51 steam generator of Westinghouse three-loop plants.

On Friday Mr. Noramly bir Muslim, Deputy General for Technical Cooperation at the International Atomic Energy Agency (IAEA) in Vienna, met with Chairman Zech, Commissioner Rogers, Harold Denton of GPA, Jim Shea of GPA/IP, and other GPA/IP staff to discuss the IAEA's technical cooperation program.

STATE, LOCAL AND INDIAN TRIBE PROGRAMS

Southeast Low-Level Radioactive Waste Compact Commission Meeting

Robert Trojanowski, Director of the Region II State and Government Affairs Staff, attended the Southeast Compact Commission for Low-Level Radioactive Waste Management Annual Meeting on October 24-25, 1988 in Roanoke, "irginia. Kathryn Visocki was elected Executive Director of the Compact mmission. She replaces Robert Wolle, who resigned for health reasons. Representatives from North Carolina made a presentation on the status of the State's effort to site a LLW disposal facility. The State has met all its milestones to date and intends to have a disposal facility in operation by January 1, 1993. North Carolina intends to issue a contract for site selection on December 1, 1988; choose a site operator by January 31, 1989 and nominate at least two and perhaps more sites for site characteriction by August 1, 1989. The Compact Commission agreed to comment on the NRC proposed rule to reassert NRC's sole authority for approving onsite LLW disposal in Agreement States. The Commission will oppose the propose rule change for a variety of reasons including its belief that the Low-Level Radioactive Waste Policy

Act and the 1985 Act Amendments make low-level waste disposal a State responsibility and that the proposed rule is ambiguous.

Meetings with Montana, Utah and Wyoming State Officials

John Montgomery, Region IV Deputy Administrator, and Charles Hackney, Region IV State Liaison Officer, met with the State Liaison Officers from Montana, Utah and Wyoming on October 24, 25 and 26, 1988, respectively. The meetings provided an opportunity to discuss Agreement State issues, low-level waste issues and NRC/State interface. Emergency response for transportation accidents was also discussed.

Texas LLW Disposal Status Report

Rick Jacobi, General Manager of the Texas Low-Level Radioactive Waste Disposal Authority, visited the Region IV office on October 27, 1988 to brief Region IV staff on the status of efforts in Texas to site and develop a low-level waste disposal facility.

Low-Level Radioactive Waste Forum

Steve Salomon, SLITP, attended the quarterly meeting of the LLW Forum held in Knoxville, TN, October 17-18, 1988. Compact and State representatives heard presentations by NRC, DOE and the sited States on the 1990 Congressional milestone pertaining to Governors' Certifications for proposed storage, disposal or management actions in lieu of applications for disposal facilities. George Pangburn, Paul Lohaus, and Malcolm Knapp, all from the Division of Low-Level Waste Management and Decommissioning, represented NRC in these discussions. Staff estimates that 32 States will submit Governors' Certifications. Only Texas will submit a complete license application. The Southwestern and Central-Midwest Compacts are expected to submit license applications for

all waste except for the small amount of mixed waste generated in their regions.

Other subjects of concern to the States that were siscussed include the progress being made by EPA in its LLW standard, and the impediments that mixed and NARM waste controversies may cause in timely disposal operation. Generally, most of the States and compacts reported steady progress toward creating new disposal capacity.

LLW Forum participants made site visits on October 19 to the CLK Ridge National Laboratory X-10 waste storage and disposal facilities and the Y-12 waste disposal facility and remediation projects. Of special interest to the States is the DOE adaptation of the French earth-mounded concrete bunker disposal facility, the LLW silos, and the Toxic Substances Control Act (TSCA) incinerator for mixed waste. In addition, the Quadrex decontamination and processing facility and the Scientific Ecology Group supercompactor and waste oilburner facilities were visited. Some of these technologies are of interest to the States and the issue of technology transfer from the Federal government to the States was explored.

Meeting of Pennsylvania LLW Advisory Committee

On October 25-26, 1988, John McGrath, Regional State Agreements Officer, attended a meeting of the Pennsylvania Low-Level Radioactive Waste Public Advisory Committee. M. McGrath made a presentation on the NRC Agreement States program emphasizing limited Agreement State status. It is the State's intention to pursue limited Agreement State status for the licensing of a LLW disposal facility. Pennsylvania is the host State for the Appalachian Compact. The Committee membership had questions regarding the agreement process, State flexibility regarding compatibility requirements and the status of the State's regulations which have undergone NRC review. The Committee also discussed the process and schedule for Committee review of operator bid proposals. The proposals are due on November 9, 1988. Public meetings, during which bidders will discuss their proposals and answer questions, will be held during the month of December. An operator will be selected and a contract executed by late spring, 1989. The operator will be selected by the Secretary, Department of Environmental Resources, after consideration of reports submitted by the Department staff, the Public Advisory Committee and comments submitted by the public.

OFFICE OF PERSONNEL ITEMS OF INTEREST Week Ending October 28, 1988

Arrivals and Departures

Four new employees joined the staff this week: Linda Kasner, Health Physicist (Medical) for Region IV; Inez Johnson, Travel Clerk, for Region II; and Gisela Abruscato, Secretary for NMSS. Sherry Matz, a part-timer, joined Region III as a Resident Clerical Aide.

Departures included three employees from NRR: Oliver Lynch, Section Chief; Eileen Cokenias and Carolyn Williams, both secretaries. Region I losses were Alan Luptak, Sr. Resident Inspector and Julie Madden, Physical Security Irspector.

Supervisory Drug and Alcohol Training

A pilot session of the Supervisory Drug and Alcohol Training was presented to approximately 30 managers and supervisors selected from the various offices within NRC, on Thursday, October 27, 1988. Trainers were Willard O. Foster of Triton Corporation and Pat Kaplan of the Employee Assistance Program, Office of Personnel. Participants were requested to provide comments and recommendations on the program which will be presented to all NRC managers and supervisors in Headquarters and the Regions.

Job Fairs

An OP representative participated in the "Job Fair for Mature Workers" on October 26, 1988. The Job Fair, sponsored by the Montgomery County Department of Family Resources, Division of Elder Affairs, was held at the Charles E. Woodward High School in Rockville. Approximately 40 companies and Federal Agencies were represented. Participating individuals represented a wide spectrum of occupations.

A recruiting team composed of Gloria Heckstall, OP, and Deborah Jackson. Project Engineer, NRR attended the Mid-Atlantic Region Conference for the Society of Women Engineers in College Park on October 28, 1988. This event was sponsored by the University of Maryland, Department of Engineering.

Negotiations

Bi-lateral negotiations continue between NRC and the National Treasury Employees Union (NTEU), on the following topics: Performance Appraisal, Reduction-in-Force, Moves and Reorganizations and Merit Selection. The Management Team consists of Greg Benoit, Chief, Negotiator, other members of the OP staff, and Mary Hembree, OGC, with the following representatives of other offices, when available: Marvin Peterson, GPA; Bob Erickson, NRR; Jessie Funches, NMSS; Al Burda, RES; Eileen Mason, ARM; Al Herdt, Region II; and Gen Roy, Region III.

Office of Enforcement Items of Interest Week Ending October 28, 1988

The following Significant Enforcement Actions were taken the week of October 24, 1988.

A Notice of Violation and Proposed Imposition of Civil Penalty in the amount of \$50,000 was issued on October 21 1988 to Iowa Electric Light and Power Company (Duane Arnold). The action was based on a violation of the equipment qualification requirements of 10 CFR 50.49. (EN 88-87)

A Notice of Violation and Proposed Imposition of Civil Penalty in the amount of \$50,000 was issued on October 24, 1988 to Duke Power Company (Catawba Units 1 and 2). The action was based on violations of the equipment qualification requirements of 10 CFR 50.49. (EN 88-86)

An Order Modifying Linese (Effective Immediately) and Notice of Violation was issued on October 24, 1988 to Hole Truth, Inc., Oklahoma City, Oklahoma. The action was based on numerous violations in the radiation safety program. The Order requires the licensee to obtain independent consulting services to perform audits for two years to evaluate adherence to NRC requirements. (EN 88-91)

A Notice of Violation and Proposed Imposition of Civil Penalty in the amount of \$150,000 was issued on October 25, 1988 to Nebraska Public Power District (Cooper). The action was based on violations of the equipment qualification requirements of 10 CFR 50.49. Because of the licensee's failure to take corrective actions for the violations as well as the fact that NRC identified all of the violations, the base civil penalty was escalated 100%. (EN 88-88)

A Notice of Violation and Proposed Imposition of Civil Penalty in the amount of \$500 was issued October 27, 1988 to Ford Motor Company, Dearborn, Michigan. The action was based on a violation involving the improper disposal of a generally licensed nuclear gauge containing approximately one curie of americium-241. (EN 88-90)

A Notice of Violation and Proposed Imposition of Civil Penalty in the amount of \$500 was issued October 27, 1988 to Davis Great Guns Logging, Wichita, Kansas. The action was based on violations including inadequate control of licensed material, failure to identify and post radiation areas, failure to conduct semiannual equipment inspections and conduct visual checks of logging equipment, and failure to maintain records of the use of licensed material and training. (EN 88-89)

Civil Penalties Paid

Wise Appalachian Regional Hospital, Wise, Virginia paid the proposed civil penalty in the amount of \$1,250. The action was based on failure to:
(1) label syringes or syringe shields containing radiopharmaceuticals,

(2) label vial radiation shields that contain a vial of radiopharmaceuticals,(3) issue written permission to a visiting physician as an authorized user,

(4) post a restricted area, (5) conduct a quarterly Radiation Safety Committee meeting, (6) perform a formal annual review of the radiation safety program, (7) provide in-service and initial training to ancillary personnel, and

(8) perform quarterly dose calibrator linearity tests. The base civil penalty was decreased by 50% based on the licensee's prompt and extensive corrective actions. (EA 88-204)

Baltimore Gas and Electric Company (Calvert Cliffs Units 1 and 2) paid the proposed civil penalty in the amount of \$150,000. The action involved two events in which Technical Specification Limiting Conditions for Operation were violated. In the first, one of the two emergency diesel generators required for Unit 2 was inoperable for approximately 48 hours because the voltage regulator was left in manual after testing. In the second, all the variable high level and axial offset Reactor Protective System instrumentation channels on Unit 1 were set less conservative than required. The base civil penalty was escalated 50% because of prior poor performance in the first violation and prior notice of a similar problem in the second violation. (EA 88-202)

Pennsylvania Power and Light Company (Susquehanna Units 1 and 2) paid the proposed civil penalty in the amount of \$50,000. The action was based on a violation of the equipment qualification requirements of 10 CFR 50.49. (EA 88-143)

Commonwealth Edison Company (Braidwood Nuclear Power Station) paid the proposed civil penalty in the amount of \$50,000. The action was based on two separate examples of inattentiveness on the part of security officers assigned as compensatory measures for an unlocked and unalarmed vital area door. (EA 88-174)

Payne and Payne, Inc., Shawnee, Oklahoma paid the proposed civil penalty in the amount of \$1,600. The action was based on failures to calibrate, perform surveys, evaluate personnel dosimetry, leak test and inventory sea'ed sources, enter into an agreement with well operators as owners or to responsibilities in event of a down-hole irretrievable source, and follow DOT regulations. (EA 87-205)

Other

The staff issued a Notice of Violation on October 21, 1988 to Tennessee Valley Authority. The action involved material false statements associated with Mr. White's statements to the NRC.

Week Ending October 28, 1988

Interim Food Service at DWFN

On Friday, October 28, an interim food service was started in the brown bag area on Floor 2. This service is being operated by Blind Industries and Services of Maryland between 7:00 am and 2:00 pm each business day and will continue until the permanent facility is open. In the morning, breakfast sandwiches, coffee and doughnuts will sold. At lunchtime, salads and sandwiches prepared that day off site will be sold. Milk, yagurt, canned soup and other mic owaveable foods and snacks also will be available.

Temporary Parking Lot

The developer's project manager estimates completion of the construction for the temporary parking lot behind GWFN in approximately 3 weeks. In preliminary discussions, the developer has indicated his intention to charge \$50./month for single-occupant vehicles and \$25./month for sarpeols.

Space Planning for TW N

The architect has submitted the first iteration of profiningry blocking plans for Floors 2 through 6 for NRC review. CONS has met with the affected offices to solicitand discuss their comments. CONS is coordinating the comments to be incorporated into the architect's next iteration of blocking plans.

S birt on Mebl Lity Conference

On Detaber 18, the Director, CONS spoke at the Sur 'ban Mobility Conference. While there, he chaired a deal-out summion to circuss NRC's traffic mitigation plan. The conference, by invitation only, was attended by 30 area newelopers and large employers. Alfred Dell Bovi, Administrator of the Urban Mass Transportation. Administration presented a check for \$22 million to Sydney Kramer, Montgomery County Executive for public parking construction in the county. Senator Serbanes, Congresswaman Montella, human Christeller, Montgomery County Planning Board Chairman and Robert McGarry, Montgomery County Planning Department of Transportation Director, slee were present.

NRC's traffic mitigation plan and efforts at reducing the single-occupant vehicle trips are being lauded by to attend expeditives as an unprocedented accomplishment among arebenphoyers. At DWFN, the NFC has schiused 20% r dorship in public transportation and 27% participation in respectits.

The Region IV Special Assistant and the Regional State Liaison Officer met with representatives from the states of Montana, Utah, and Wyoming on October 24, 25, and 26 and discussed Agreement States issues, low-level waste, and NRC state interfaces.

NMSS Assessment

Hugh Thompson, the Director, Office of Nuclear Materials Safety and Safeguards, and Richard Cunningham, Malcolm Knapp, and Jesse Funches of his staff visited Region IV on October 25 for discussions on NMSS programs with regional management involved in NMSS programs.

3. Visit with Texas State Official

Mr. Rick Jacoby, General Manager, Texas Low-Level Radioactive Waste Disposal Authority, visited the Region IV office on October 27 and met with the Regional Administrator, Special Assistant, and other Region IV senior managers to discuss low-level waste disposal issues and the development of the Texas low-level waste disposal site. Mr. Jacoby also met with the Region IV technical staff to discuss site devalopment and operational procedures of the Texas low-level waste disposal site.

I. SECY-88-243 - Release of PDR User Information

The Commission,* with Commissioners Roberts, Carr, and Rogers agreeing, has approved a policy statement, as modified to incorporate Commissioners' comments, which establishes NRC employee procedures when requested to release information on users of the Public Document Room. Chairman Zech, while supporting the intent of the policy statement, believed that a Manual Chapter was sufficient to guide the staff when confronted with such requests.

The Commission, with all Commissioners agreeing, also requested the Office of the Secretary and the Office of the General Counsel to develop an appropriate Manual Chapter implementing the policy statement.

II. SECY-88-274 - Closing Out ALAB-883 (Holding Siren Issues to be Resolved Before Low Power), Public Service Company of New Hampshire (Onsite Emergency Planning and Safety Issues)

The Commission, with Chairman Zech and Commissioners Carr and Rogers agreeing, approved an order which:

- (1) Stipulates that only those offsite standards specified in 10 CFR 50.47(d), as amended, are to be prerequisites to low power testing.
- (2) Specifically vacates the Appeal Board's order that authorization of low-power operation may not be given effect until the contested issues about such a system are resolved favorably for Seabrook.
- (3) Directs the Chairman of the Atomic Safety and Licensing Board Panel, in consultation with the Seabrook "onsite" and "offsite" Atomic Safety and Licensing Boards, to determine which of those Licensing Boards should try the prompt notification issues.

Commissioner Roberts was on travel and unavailable to

^{*} Section 201 of the Energy Reorganization Act, 42 U.S.C. Sec. 5841, provides that action of the Commission shall be determined by a "majority vote of the members present." Commissioner Roberts was not present when this item was affirmed. Accordingly, the formal vote of the Commission was 2-1 in favor of the decision. Commissioner Roberts, however, had previously indicated that he would approve this paper and had he been present he would have affirmed his prior vote.

Chairman Zech encouraged the licensee, the state and local officials with the involvement of the staff and FEMA as necessary, to continue working together on the emergency planning issue at the Pilgrim site.

The Commission requested the staff to keep the Commission informed on Boston Edison Company's progress during the power ascension program, should the Commission approve restart.

The Commission* was briefed by the staff on different cask designs for shipping and storing nuclear materials, i.e., spent fuel.

The Commission encouraged the staff to continue working with the Department of Energy, utility licensees and shipping cask fabricators to achieve cask design compatibility to the greatest extent possible. With NRC taking a leadership role, active participation by the utilities and the industry should be sought to achieve this goal.

Commissioner Rogers requested the staff, in their consideration of the designs of casks, to separate those designs for transport and repository storage from those designs for onsite storage, and to assign a higher priority to the achievement of compatibility among transport and repository storage casks while simultaneously expediting the review of proposed onsite storage cask designs.

The Commission requested the staff provide a paper addressing the resources needed to handle license applications for cask designs.
