This quarterly report is submitted in compliance with Condition No. 29 of the above-referenced Source Material License.

## PROJECT STATUS

Except for radiation and environmental monitoring in compliance with the Source Material License and the Wyoming Department of Environmental Quality Research and Development License, and site maintenance and security, there has been very minimal activity at the project site. The project is currently being maintained in a groundwater monitoring and stabilization mode.

## RADIATION AND ENVIRONMENTAL MONITORING

Air sampling for radon and/or radon daughters, and for uranium particulates continues to indicate concentrations less than 25 percent of the applicable maximum permissible concentrations specified by 10 CFR 20. Monitoring for radon and/or radon daughters continues to indicate levels less than 0.01 Working Levels and less than 0.01 Working Level Months.
