MEETING SUMMARY

Subject: Interagency Meeting on Sequoyah Fuel Facility

On July 16, 1986, representatives of the NRC, Environmental Protection Agency (EPA), and the Federal Emergency Management Agency (FEMA) met in the NRC Region IV office to discuss the Sequoyah Fuels Corporation, Gore, Oklahoma facility. The attendance list is attached as Appendix A to this Summary.

The purpose of the meeting was to discuss issues concerning onsite and offsite emergency preparedness at the Sequoyah Fuels Facility. The EPA and FEMA representatives stated that they would not be able to make a determination of adequacy for emergency planning until they had reviewed the revised Contingency Plan and the Contingency Plan Implementing Procedures (CPIP). Each agency discussed review schedules, regulatory requirements and agency interfaces. The NRC suggested that EPA and FEMA may wish to accompany the NRC on the next inspection of the Sequoyah Fuel Facility in order to review the CPIPs onsite and observe licensee interface with offsite officials.
