This refers to Item Number 15 of Amendment No. 42, dated October 22, 1998, to U.S. Nuclear Regulatory Commission License Number 08-01297-06, Docket Number 030-7130, and your letter of October 22, 1998.

The following is a status report for the 1ST calendar quarter ending March 31, 1999, regarding the activities associated with the termination of all licensing activities at the Federal Emergency Management Agency's (FEMA) National Instrumentation Center (NIC), Mt. Weather Emergency Assistance Center (MWEAC).

The FEMA Radiation Control Committee (RCC) met to conduct business on January 21, 1999, and March 18, 1999.

The FEMA Radiation Control Committee (RCC) authorized the FBI to use CDV-104, which had been transferred to the U.S. Army TMDE, Redstone Arsenal under NRC License 01-00126-19, at MWEAC.

An audit of the Radiation Protection Program was conducted on March 16, 1999. Findings were discussed with the FEMA Radiation Control Committee.

FEMA is continuing to find homes and transfer FEMA-owned radioactive sources to the States and other Agencies who are properly licensed/authorized to possess and use the radioactive sources.

Radioactive Sources which are no longer required by the States or other Agencies will be disposed of as radioactive waste by arranging to have these sources properly disposed of as radioactive waste.


