We have completed our review of your responses to Generic Letter (GL) 83-28 dated September 2, 1983, November 4, 1983, February 29, 1984, April 30, 1984, and September 28, 1984. Your responses were evaluated for compliance to the staff's positions delineated in GL 83-28 for Action Items 3.1.1, 3.1.2, 3.2.1, 3.2.2, 4.1, and 4.5.1. Your responses to items 3.1.1, 3.1.2, 3.2.1, 4.1, and 4.5.1 were found to be adequate and meet the intent of GL 83-28; however, your response to item 3.2.2 was determined to be incomplete. Descriptions of the deficiencies are discussed in greater detail in Section III of the enclosed Safety Evaluation and in the enclosed Request for Additional Information. In order to maintain our present review schedule, we request that you respond to the enclosed request for additional information within 30 days or provide a date that you can meet within 15 days or receipt of this letter.
