Hi Laura,

Happy to help. I can confirm the Dr. L has been approved for these (as well as 35.600/1000 Perfexion GSR), and I've attached a letter I sent for a resident earlier this year. If you need something current, I'm happy to redo it – please note that it lists the approval dates for Dr. L from our RSC.

On a completely different note, I was hoping you may be able to provide some advice. We've had a simple amendment in (change from one experience RSO to another) since early January 2020 – I received the license reviewers contact information, and have sent a few emails and tried calling a few times, to no avail. It has been more than 90 days (also early Jan) since we received the acknowledgement letter from the NRC (the “we’ve reviewed your submission and nothing seems to be missing, we’ll look at it in detail and get back to you” letter). Is there a way to escalate this or get some action initiated? I'd appreciate any advice.
