SUPPLEMENT TO REQUEST FOR LICENSE AMENDMENTS
REVISION OF SUPPRESSION CHAMBER POOL WATER VOLUME

Gentlemen:

On July 8, 1997, Carolina Power & Light Company submitted, in accordance with 10 CFR 50.90 and 10 CFR 2.101, a request for revision to the Technical Specifications for the Brunswick Steam Electric Plant, Unit Nos. 1 and 2. These proposed amendments were to relocate and revise minimum and maximum suppression chamber pool water volumes contained in Technical Specification 3.6.2.1.a.1, to support installing larger Residual Heat Removal and Core Spray system suction strainers.

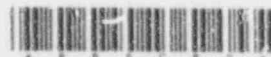
The Bases Section pages (B 3/4 6-3) associated with July 8, 1997, amendment request were impacted by the issuance on November 1, 1996, of the power up-rate amendments, No. 183 to Facility Operating License No. DPR-71 (Unit 1) and Amendment No. 214 to Facility Operating License No. DPR-62 (Unit 2). The Unit 1 power up-rate amendment became effective on the completion of the B111R1 refueling outage and the Unit 2 amendment will become effective prior to start-up from the B213R1 refueling outage scheduled to start in September 1997.

The enclosed typed Bases pages (B 3/4 6-3) incorporate the power up-rate amendments, and are provided as a replacement, addressing the administrative error with the associated typed Bases pages submitted with the July 8, 1997, amendment request.


