SUMMARY OF MEETING WITH APPLICANT ON OCTOBER 29, 1974 REGARDING
SLOPE STABILITY

On October 29, 1974, representatives of WPPSS, Ebasco, and Woodward-Lundgren met with the Regulatory staff in Bethesda. WPPSS had requested the meeting to allow their geologic consultant to present additional information regarding slope stability and landslides in the site area. A list of attendees is contained in Enclosure No. 1.

Woodward-Lundgren explained the slope stability analysis described in Section 2.5 of the PSAR. He commented that the figures in the PSAR in the slope stability subsection are not clear. As a result, we have not been able to identify the steepest slopes on these figures. He stated that the conclusions about the origin of landslides that have occurred in the site vicinity should be given more support. This will require additional field work.

At WPPSS' request, we clarified the following questions in our October 11, 1974 request for additional information: 323.1, 323.6, 323.8, 323.10 and 323.12.

No new information on slope stability and landslides was presented.








