Dear Sir or Madam:

In accordance with 10 CFR 50.54 (p)(2) and 10 CFR 50.4 (b)(4), Carolina Power & Light Company is providing Revision 1 of the "Physical Security and Safeguards Contingency Plan" for the Harris Nuclear Plant. A copy of the Physical Security And Safeguards Contingency Plan is being provided as Enclosure 1 to this letter. A description of changes is provided as Enclosure 2 to this letter.

The changes to the Physical Security and Safeguards Contingency Plan include: (1) a change to the Security Computer System that will only permit the use of a card reader card at the entry turnstiles once it has been used to exit the Protected Area, (2) provides that the plant security program shall be reviewed by individuals independent of both security program management and personnel who have direct responsibility for implementation of the security program at intervals not to exceed 12 months, or, as necessary based on an assessment against performance indicators, and as soon as reasonably practicable after a change occurs in personnel, procedures, equipment or facilities that potentially could adversely affect the safeguards contingency plan or security program, but no longer than 12 months after the change. In any case, each element of the safeguards contingency plan and the security program must be reviewed at least every 24 months. The enclosed revision does not decrease the effectiveness of the plan or the level of security provided.

Enclosure 1 contains Safeguards Information and requires protection in accordance with 10 * JE53 1/4 CFR 73.21. When separated from Enclosure 1, handle this cover letter and Enclosure 2 as decontrolled.
