Response to July 2, 1999 Request to Review Monticello Data in Reactor Vessel Integrity Database (TAC No. MA1199)

In a letter dated July 2, 1999, from Carl F. Lyon of the U.S. Nuclear Regulatory Commission (NRC) Staff to Roger O. Anderson of Northern States Power (NSP) Company, NSP was requested to review data for the Monticello reactor pressure vessel that was entered in the NRC Reactor Vessel Integrity Database. This letter responds to that request.

The Reactor Vessel Internals Data Base has been thoroughly reviewed for the Monticello specific data input to the data base. The following corrections are recommended:

Title of display: Plate Detail

Identification of data set: Plate ID 234

Data entries in question: USE @ EOL (1/4T): 47.8

% Drop @ EOL (1/4T): 32.7

Recommended values: USE @ EOL (1/4T): 56.2

% Drop @ EOL (1/4T): 20.9

Discussion: The % Drop @ EOL (1/4T) of 32.7 and the USE @ EOL (1/4T) of 47.8 appear to be incorrect. We believe that the correct value for % Drop @ EOL (1/4T) should be 20.9 and the correct value for USE @ EOL (1/4T) should be 56.2 ft-lbs. These are the values identified in our letter from William J. Hill to the U.S. Nuclear Regulatory Commission dated September 5, 1997, "Response to Request for Additional Information (RAI) on Monticello Power Rerate Program (TAC No. M96238)" which reflect currently accepted vessel material performance criteria.
