Mississippi Power & Light Company (MP&L), on behalf of System Energy Resources, Incorporated and South Mississippi Electric Power Association, herewith files, in accordance with 10CFR2.110(a), Revision 1 to the Security Training and Qualification Plan for the Grand Gulf Nuclear Station (GGNS) Units 1 and 2. Pursuant to 10CFR2.790(d)(1) and 10CFR 9.5, this information should be considered confidential and withheld from public disclosure. The enclosed revision was approved by the Plant Safety Review Committee on 11/17/86.

Middle South Energy, Incorporated (MSEI) has changed its name to System Energy Resources, Incorporated (SERI) and, upon NRC approval of an application to suitably amend the operating license and construction permits, will assume responsibility for operation of the GGNS which has formerly been operated by MP&L acting as agent for the owners. SERI continues to share ownership with and will act as agent for South Mississippi Electric Power Association. This revision is being submitted to incorporate these changes and will become effective upon approval of the requested amendments expected in early December 1986. This revision has been evaluated and determined that it will not decrease the effectiveness of the Training and Qualification Plan when implemented and determined to meet the provisions of 10CFR50.54(p).


